I refer to the above details. An appeal has been made to the Secretary of State against the decision of Stafford Borough Council to refuse to grant planning permission.

The appeal will be determined on the basis of an **inquiry**. The procedure to be followed is set out in the Town and Country Planning Appeals (Determination by Inspectors) (Inquiry Procedure) (England) Rules 2000, as amended.

The appeal will be heard at a Public Inquiry as an in-person event at Stafford Rugby Club, Blackberry Lane, Stafford, ST16 2TT commencing at 10.00 am on 16 May 2023 and is anticipated to be heard over four days; 16-18 May 2023 in person at the Rugby Club and a proposed additional day for the parties involved online on 23 May 2023.

The Inspector appointed who will decide this appeal is Gareth Jones MRTPI. The appeal will be decided by the Inspector under powers transferred by the Secretary of State.

It would be helpful if you could confirm by **Friday 5 May 2023** whether you are planning to attend, in order to help the Council make arrangements so that attendees are accommodated.
